TOWN OF MERRILL**

**Town of Merrill, Lincoln County, Wisconsin  
Establishment of Ward Boundaries**

WHEREAS: Section 5.15 of Wisconsin Statutes provides for mandatory wards in order to accommodate the County Supervisory Districts and for towns of 1,000 population or higher bases on the 2020 Census, and

WHEREAS: The Tentative Lincoln County Supervisory Plan has been submitted to the Town.

THEREFORE, IT IS HEREBY RESOLVED that the Town of Merrill establishes Wards conforming to the County Tentative Supervisory Plan. The Wards are described as follows with map attached:

**Ward 1 – Supervisory District 22 – Population 369**

*That portion of the town south of a portion of Olivotti Lake Road and Rock Falls town line being the North boundary – East boundary is the East boundary of District 22 – South Boundary is portion of Spring Lake Road and portion of North Star Drive - West boundary being the-Town of Rock Falls town line.*

**Ward 2 – Supervisory District 9 – Population 679**

*That portion of the town south of a portion of Spring Lake Road being the North boundary – East boundary is a portion of Holdorf Drive and Town of Schley town line – South boundary is portion of Pine River town line and portion of Highway G -Portion of town east of portion of Highway 51 and east of portion of the Prairie River and east of a portion of County Road K being the West boundary.*

**Ward 3 – Supervisory District 21 – Population 869**

*That portion of the town south of a portion of North Star Drive East of Highway JJ and West of Highway 51 being the North Boundary - East boundary being portion of town west of portion of Highway 51 and portion of the Prairie River & the east boundary of district 9 – South boundary being portion of Highway G and City of Merrill town line – West boundary being portion of HWY JJ and City of Merrill boarder.*

**Ward 4 – Supervisory District 5 – Population 274**

*That portion of the town south of Wayside Drive, the South Side of a portion of Highway 107 east of Joe Snow Creek and portion of Hillside Drive being the North Boundary - East boundary being portion of Champagne Drive and Council Grounds Drive – South boundary being portion of Wisconsin River – West boundary being Joe Snow Creek.*

**Ward 5 – Supervisory District 21 – Population 386**

*That portion of the town south of portion or Rock Falls town line and portion of North Star Drive being the North Boundary – East boundary being the portion of Highway JJ south of North Star Drive – South Boundary being the portion north of Wayside Drive, the north side of a portion of Highway 107 and portion of Hillside Drive– West boundary being portion of South End Road.*

**Ward 6 – Supervisory District 22–Population 304**

*That portion of the town south of portion of Mathews Road being the North Boundary – East boundary being portion of South End Road south of Town of Rock Falls town line and portion of Highway 107 west of Joe snow Creek – South boundary being portion of Wisconsin River Including 2 Wisconsin River Islands – West boundary of district 22 the West Boundary.*

BE IT RESOLVED that for all voting purposes the above wards will be combined, using one common polling place, which is named Town of Merrill Community Center, W4594 Progress Avenue.
